Understanding Ordinance 915

Part 5: Class I and Class II Licenses Code Enforcement & Neighborhood Conservation

Class I and Class II Licenses are issued to owner-occupied properties. It may be that you have roomer (or two) in your single-family home. Or, it may be that your half of the duplex has roome you rent the other side. Either way, if you live and rent at the same address, you will be issued I or CLASS II license.

Class I licenses are renewed once every three years. These licenses are issued to owner-occu rentals which have occupancy of one person (roomer).

Class II licenses are renewed once every two years. These licenses are issued to owner-occup single family rentals which have occupancy of two or more persons (roomers).

How do you know which license you have? The classification is written on the license. Also, the classification depends on how many roomers you are licensed to have.

1 roomer = Class I	roomer = Class I More than 1 roomer = Class II	
Renew every 3 years.	Renew every 2 years.	
Inspect once every 3 years.	Inspect once every 2 years.	

What will happen this year?

On July 1, 1998, your license will change to reflect your new renewal dates. If you have not rec new license by July 10, 1998, please call the office to find out why. Your inspection will take pladays prior to renewal of the license. Please see the charts on the back and keep them as refer when you are to renew the license.

What if I rent both sides of my duplex?

If you rent both sides of your duplex, you will be issued a Class I or Class II for the side you live (owner-occupied) and a Class III or Class IV for the other side (non owner-occupied). You will be licenses on the property and each license will show the address and classification for that address

A Class III or Class IV will be inspected every year and renewed every year.

The Class I or II license will be inspected and renewed on a different schedule.
